The Commission will receive a briefing on the Caltrans State Route 37 interim and long-term highway improvements and developments projects along the entire corridor, from Highway US 101 (Novato, Marin) in the west to I-80 in the east (Mare Island, Vallejo). The briefing is a follow-up of the last April 2022 briefing with an update on the State Route 37 Planning and Environmental Linkages Study (long-term solution) including the selected alignment, next steps, timelines and funding, as well as interim projects designed to keep this critical regional connector operational in the near-term.

 Public Hearing and Vote on an Enforcement Committee Recommended Enforcement Decision, including Proposed Cease and Desist Order and Civil Penalty Order Number CCD2022.007.00 (BCDC Enforcement Case ER1988.024.00)

The Commission will hold a public hearing to address the permit violations and unauthorized development in the 100-foot shoreline band at a cul-de-sac known as John's Place in the City of Benicia, Solano County, and vote whether to adopt a Recommended Enforcement Decision proposed by the Enforcement Committee which includes a proposed Cease and Desist and Civil Penalty Order to require remedial actions at the site and payment of \$61,110 in administrative civil liability.
