On behalf of the Regional Bay Area Building Trades Councils, we would like to express our strong support for SB 273, which would authorize a mixed-use project located on Piers 30-32 in the City and County of San Francisco.

Piers 30-32 is a critical asset supporting core maritime and emergency response functions in the City of San Francisco. Unfortunately, the Pier is in a deteriorated condition and is projected to become unusable in 10 to 15 years. Already, large portions of the pier are “red tagged” and fenced off from use. The project would remove the existing pier and replace it with a new, much smaller pier, thereby creating significant resilience and Bay quality benefits. With rising sea levels, the existing Pier and adjacent Embarcadero roadway are greatly at risk of inundation and the project would also make critical seismic upgrades and raise the elevation of both the Embarcadero and the Pier to above year 2100 projected Sea Level Rise (SLR) levels.

Given limited revenues, three years ago the Port of San Francisco issued a Request for Proposals to a form a public private partnership to invest in the rehabilitation of the Piers and activate the waterfront at this location. The selected development proposal successfully balances he objectives of the Public Trust (supporting maritime commerce, increasing public access, furthering environmental sustainability) with the need to spur private investment into the Pier. In fact, as part of the overall \$1.2 billion project, the development will make a \$400 million infrastructure investment in resiliency, pier and seawall upgrades, and public access, which is funding the Port does not currently have. And this will all be accomplished using full union labor.

SB 273 paves the way for this project by making important findings as to the overall Public Trust benefits of the project, while allowing for a general office use on a limited basis – the latter of which is necessary to help pay for the \$400 million in infrastructure investment and providing over 1,250 union construction jobs.

**Subject: California SB 273 Legislation on Port of SF Piers 30/32**

Dear Steve,

On behalf of the staff of the Port of San Francisco I am writing to express our surprise to see the above listed on the BCDC Commission calendar on April 20<sup>th</sup> after sharing the draft legislation with your Executive Director in late February and repeatedly seeking BCDC's participation and collaboration in drafting the bill.

In reviewing the staff report, we found several inaccurate statements and omissions regarding the legislation and the project as proposed. As you know, the Port and project sponsor spent approximately 18-months working with BCDC and State Lands Commission staff to "shape" the project to better align with BCDC's mission and policies and as directed by your Commission at our last hearing for this project on June 17, 2021. We believe that time was well spent and led to a significantly improved project. Details of the proposed piers project were provided to BCDC staff on numerous occasions including as recently as October 2022 and no changes to the Piers 30-32 project proposal have occurred since.

Please find below corrections to certain inaccurate statements and omitted project details we felt should have been included, as well as some background on related Port-BCDC collaborations that we believe are relevant to this discussion:

Inaccurate statements:

1. The project proposes approximately 375,000 square feet of general office, not 500,000 square feet;
2. The Port of San Francisco has met all of its obligations of the SF Special Area Plan (SAP) due as of today's date. In fact, the Port delivered many of the SAP obligations early, benefiting the public and the Bay even in situations where the

enhancements were delivered prior to the approval of the associated pier developments under the plan;

3. The staff report states:

*“For over 50 years, BCDC’s law and policies have reserved the Bay for Bay-oriented uses that are public trust consistent, such as for ports, marinas, and public recreation. In that time, BCDC has not approved such a major project on the Bay with general office unless that general office space is ancillary to the project itself”*

BCDC has issued major permits for mixed use projects that include general office, including the Ferry Building, Pier 1, Piers 1.5-5 and the Exploratorium, to name a few within San Francisco.

4. The proposed legislation does not in any way reduce BCDC’s authority to Permit the project through a Major Permit. The only authority it addresses is the need for BCDC to make the Public Trust finding, which in this case we are asking the Legislature to do based on the unusual nature of Piers 30-32 and the benefits the proposed project would provide. This approach is similar to prior legislation done for the site as you reference such as the Bryant Street Piers (AB 1389 – 2001/03) and Golden State Warriors (AB 1273-2013) mixed use projects; see specifics below:

On page 22 of the SAP, the plan provides the following for Piers Not Designated for Removal (which includes Piers 30-32): *“Within the boundaries of the existing pier footprint, an existing pier may be repaired or wholly reconstructed for a use consistent with the Public Trust Doctrine and the Port’s legislative trust grant without triggering the McAteer- Petris Act Section 66605(a) water-oriented use criterion, and Section 66605(b) no alternative upland location criterion. Existing piers are those piers extant on the Northeastern Waterfront, and not identified for removal, as of July 20, 2000;”*

This legislation, like the Bryant Street Piers legislation, which BCDC collaborated on, tracks the same language from the SAP, which already exempts a project on Piers 30-32 from 66605(a) and (b). The only addition is to add this qualifier to apply the exemption to piers that are wholly reconstructed or wholly replaced.

Project Detail Omissions:

In describing the proposed project your staff report references two prior mixed-use projects that included general office use on Piers 30/32 that went through the legislative process and had Public Trust benefits. The staff report references that those projects were trust consistent but does not acknowledge that those projects were found to be trust consistent by the legislature, as noted above. Further, in describing this project, the report neglects to describe the suite of Public Trust and community benefits that the current proposed project offers, including:

1. Five acres of public access areas including full perimeter access around the Pier and indoor space, which is consistent with the SF SAP criteria for public access;
2. The aquatic center for access to in-bay swimming; a swimming pool, a Bay Area Water Trail launch and destination site;
3. A secondary cruise terminal berth, which will also be used for disaster response, research and ceremonial berthing;
4. Removal of approximately 6-acres of Bay shadow fill and significant bay volume reductions, which in the aggregate represents more fill removal than would be allowed under an interpretation that required some portion of the current structure to be retained;
5. Bay habitat creation;
6. Bay water quality improvements, through stormwater treatment systems and removal of dilapidated structures;
7. A food market hall and other visitor serving retail;
8. Removal of blight; and
9. Seismic and sea level rise resilience, which is extremely significant to the Port, harbor and the San Francisco community but not yet formally recognized as a Public Trust benefit.

If you consider the suite of public trust benefits this proposed project brings compared to prior Piers 30-32 projects for which legislation was previously adopted and that BCDC described as Trust consistent, we believe that this project provides greater benefits than those previously proposed.

#### Project Context: Port-BCDC Collaborations

The dialogue around the Piers 30-32 project proposal is intertwined with two other efforts for which the Port also asks for further collaboration from BCDC staff.

The first of these is the work the Port is performing in coordination with BCDC and our other partners, including the US Army Corps of Engineers (USACE), to establish a plan for delivering infrastructure investments for a future San Francisco waterfront that is prepared for sea level rise and earthquakes. While we do not have more detailed costs for this plan as yet, we expect it will extend into the many billions of dollars. To defray these costs, the Port has appreciated the receipt of a \$425 million down payment from the San Francisco voters in the form of a general obligation bond. We know we have billions remaining to raise, and we feel that public-private development partnerships, if appropriately vetted and refined, are a way to spread this cost so it is not all borne by the taxpayer. The Piers 30-32 project is part of this strategy and would invest an additional \$400 million from private sources into infrastructure to make resilient this low-lying section of the waterfront. Port staff will be reaching out to BCDC staff to discuss SB 272 (also on the April 20 BCDC agenda) and develop a shared understanding of how BCDC's review role under the USACE Coastal Zone Management Act process will mesh with the new review authority proposed under the bill.

In addition, the Port has recently completed a five-year-long stakeholder engagement process of updating our Waterfront Plan, during which Port staff have worked closely with BCDC staff to identify potential corresponding updates to the Special Area Plan adopted in 2000 to reflect and address the conditions and challenges of today. Port staff transmitted the Port's SAP proposal to BCDC for review on December 12, 2022; while we

have met regularly to discuss with BCDC staff we would appreciate a formal response so we can move this dialogue to a shared proposal for consideration by our respective commissions.


### Conclusion

Currently our team practices at Martin Luther King Jr. pool in the Bayview, which is the only San Francisco Public pool that can be used for water polo. Our members would love to have a practice location that is more accessible to the entire Bay Area.

The pool complex includes an Olympic-size pool (which would be one of only two in all of San Francisco), which would host water polo matches, swim dance contests, lifeguard training, and recreational and competitive swim events. Additionally, a purpose-built Learn to Swim pool is included to help address the shortage of swim safety programs in the Bay Area. Unbeknownst to many, drowning is the leading cause of accidental death for children ages 4 and under, and the second highest cause of accidental death for children ages 14 and under. Importantly, the swim facility would also provide support facilities

such as changing rooms, lockers, showers, saunas, and a hot tub to cater to swimmers of all levels and ambitions, including open water swimming which will also be offered at the site.

Given limited revenues, three years ago the Port of San Francisco issued a Request for Proposals to form a public private partnership to invest in the rehabilitation of the Pier and activate the waterfront at this location. The selected development proposal successfully balances the objectives of the Public Trust (supporting maritime commerce, increasing public access, furthering environmental sustainability) with the need to spur private investment into the Pier. In fact, as part of the overall \$1.3 billion project, the development will make a \$400 million infrastructure investment in resiliency, pier and seawall upgrades, and public access, which is funding the Port does not currently have. And this will all be accomplished using full union labor.

SB 273 paves the way for this project by making important findings as to the overall Public Trust benefits of the project, while allowing for a general office use on a limited basis – the latter of which is necessary to help pay for the \$400 million in infrastructure investment and providing over 1,250 union construction jobs.

For these reasons, San Francisco Tsunami Water Polo is pleased to support SB 273 and respectfully requests your support.

Dear Chair Wasserman,

Thank you for your interest in engaging with our office on SB 273 (related to Piers 30-32). I know I speak for the sponsors of SB 273 when I say they have appreciated the opportunity to work with the Commission over the past 18 months. The Port of San Francisco provided bill language to the Commission prior to introduction and repeatedly followed up with the Commission to request feedback on the legislation.

After 18 months of engagement with the sponsors and follow-up with the Commission by my office, I was dismayed to receive no written feedback from the Commission until today – the day of the deadline for author’s amendments ahead of the bill’s planned hearing in the Senate Natural Resources Committee. The feedback I did receive was an informal list of concerns with no specific amendments attached.

While I am in conceptual support of addressing the listed concerns, the Commission’s approach — essentially blowing off the Port, declining to participate in the legislative process, and then providing last-minute informal amendment requests — makes this process much harder than it needs to be and creates significant timing challenges.

If you would please provide these recommendations in amendment form as quickly as possible, given today’s author amendment deadline, we would be happy to give them our immediate attention and work with the committee to facilitate resolution.

**RE: SB 273 (Wiener) - Oppose**

Dear Mr. Chairman and Members of the Committee:

**On behalf of tens of thousands of members and supporters of Save The Bay, we respectfully oppose SB 273 as an inappropriate, unneeded and dangerous override of the state's coastal regulatory regime that has served the public interest extremely well for decades.** The legislature should not prematurely fast-track regulatory approval of private office buildings on new fill in San Francisco Bay before any public review of project consistency with public trust, McAtteer-Petris Act and other state and local laws and land use requirements. Instead, the legislature should mandate a long-overdue study to determine what statutory changes coastal management agencies need to address sea-level rise adaptation and coastal resilience in ways that protect the public interest and resources of all of California's residents.

Save The Bay is the oldest and largest organization working to protect and restore San Francisco Bay for people and wildlife, since 1961. Save The Bay started the movement to prevent unchecked filling of San Francisco Bay, and sponsored the legislation that created the San Francisco Bay Conservation and Development Commission (BCDC), signed into law by Governor Ronald Reagan. BCDC's successful regulation of fill in the Bay and mandating of maximum feasible public access to the Bay shoreline has been an unquestioned success, spurring the creation of hundreds of miles of Bay Trail, public plazas and shoreline parks; permitting the Bay to be enlarged through large-scale habitat restoration; and retaining the Bay as natural treasure and a crucial contributor to the region's dynamic economy. As the first coastal zone management agency in the world, BCDC has become a global model, replicated in California's Coastal Commission and around the globe.

SB 273 would make legislative findings and statutory changes to advance a speculative project that has received little public scrutiny and no formal public review, significantly injuring the authority of BCDC and other regulatory agencies whose oversight over many decades has protected the public's interest. To expedite approval of the Port of San Francisco's notion to demolish Pier 30-32 and rebuild the structure anew to host hundreds of thousands of square feet of office space, SB 273 would pre-emptively declare such a project to be in the public interest and would override BCDC's authority to determine whether the project is consistent with the McAtteer-Petris Act (Section 66605 of Government Code). BCDC would not be able to assess whether an alternative upland location is feasible for the construction of new office buildings, nor whether the projects other components qualify it as meeting statutory requirements for water-oriented use justifying the creation of new fill in the Bay from wholly reconstructed or wholly replaced pier elements.

In this time of accelerating climate change whose impacts are already being felt, the legislature should be strengthening BCDC's authority, not weakening it, especially because a significant portion of the state's property at risk from rising tides is within the nine Bay Area counties where

BCDC's jurisdiction lies. SB 273 would undermine BCDC's authority to do its job, and invite other jurisdictions and developers to enlist the legislature in end runs around the agency, diminishing its ability to protect the public interest.

### **Strengthen Coastal Regulatory Agencies; Don't Weaken Them**

Per state law and San Francisco city policies, office buildings are generally not considered an appropriate use for piers that are reserved for primarily maritime and other uses that serve the public trust. Private facilities that could be located at an alternative upland location are generally prohibited from shoreline properties reserved in the public trust, so that the general public can enjoy maximum feasible access to the Bay and shoreline. The San Francisco Waterfront Special Area Plan also guides agencies' consideration of appropriate uses. As BCDC wrote to the Port three years ago about the potential Pier 30-32 project:

**“Demolishing the pier to build new piers in the Bay on which new general office buildings would be located, instead of using an alternative upland location, raises substantial issues regarding consistency with many of BCDC's laws and policies, and certainly with the public trust.”**

[Letter from BCDC to Port of San Francisco, 9/23/20]

Rather than allowing BCDC to consider a project proposal at Pier 30-32 through the normal process, with full public evaluation and input that could produce a permissible project, SB 273 declares that BCDC's core statutory authority to evaluate project consistency with its water-oriented use criterion and no alternative upland location criterion “shall not apply.” This is not only poor public policy, but also weakens the authority of BCDC to do its job and invites other legislative end-runs around the McAteer-Petris Act that has served the Bay Area and the people of California very well for over a half-century.

Proposals for reuse or reconstruction of Pier 30-32, and for new maritime or non-maritime uses of that pier, should be evaluated through the normal public processes, statutes and regulations of BCDC, the State Lands Commission, and other agencies with jurisdiction. The legislature should not dictate new uses at the behest of a private developer or at the request of a city agency acting contrary to adopted local land use plans, without public input or review. A special statute enabling shoreline development that is inconsistent with the public trust and agency statutes is not in the public interest and does damage to the authority and standing of those agencies the legislature should instead be working to strengthen.

### **Mandating Inappropriate Projects on Pier 30-32 Has Repeatedly Failed**

Two previous actions by the legislature to mandate inappropriate projects on the aging Pier 30-32 site have failed. Over 20 years ago the legislature specified that a cruise ship terminal and hundreds of thousands of square feet of office space was necessary and required special statutory authorization. The project developer subsequently abandoned that project after determining that the financial investment required to improve the substructure of Pier 30-32 was cost prohibitive, and San Francisco built a new cruise ship terminal at Pier 27.

The legislature modified that statute to mandate approval of an arena for the Golden State Warriors in 2013 (AB 1273-2013). Again, the developer concluded the project was economically and structurally infeasible and instead built the project in an alternative upland location, where it now operates as a successful sports and entertainment venue and economic driver for the city without negative impacts to San Francisco Bay or beneficial uses of the shoreline.

## **San Francisco Does Not Need More Private Office Buildings**

The Port of San Francisco's and SB 273's encouragement of a project to create new private office buildings on a wholly reconstructed pier is particularly inappropriate given current economic realities. San Francisco's office vacancy rate in the first quarter of 2023, according to CBRE, increased to 29.4%, far surpassing the previous pre-pandemic high of 19.1% during the dot-com bust in 2003. The availability rate, which includes both vacant space and leases ending soon, has already hit 34.6%, indicating that San Francisco's overall office vacancy rate is poised to rise even higher.

## **San Francisco is Investing in Shoreline Resilience and Port Adaptation to Sea Level Rise**

The Port of San Francisco has developed a substantial Waterfront Resilience Program. San Francisco voters overwhelmingly adopted Proposition A to authorize the city to issue \$425 million in general obligation bonds to advance reinforcement and reconstruction of the Embarcadero Seawall, bulkhead buildings, wharves, piers and other critical facilities for increased resilience to seismic events and to address sea-level rise and flood protection. Save The Bay and a broad range of interests endorsed that measure and worked for its successful passage. Additional resources will be required to fully implement these plans, including federal, state and local funding, and potential public-private partnerships. But neither the San Francisco Board of Supervisors nor the city's voters have adopted policies, ordinances or charter changes to fund shoreline resilience by promoting construction of new piers in San Francisco Bay or construction of private office buildings on those piers.

### **Recommended Alternative Approach:**

Instead of prematurely fast-tracking an inappropriate and unwise project and weakening the regulatory agencies whose authority to protect the public interest needs to be strengthened, the legislature should take two actions in addition to rejecting SB 273:


1. Seize this opportunity to repeal obsolete provisions of Chapter 489 of the Statutes of 2001 relating to Pier 30-32 that remain even though the inappropriate development projects they were drafted to facilitate have long since disappeared. The Port of San Francisco constructed a new cruise ship terminal in another location, without massive private office buildings. The Golden State Warriors constructed a private, indoor arena at an alternative upland location, as required by the McAteer-Petris Act. San Francisco's historically high – and growing – office vacancy rate and accelerating projections of sea-level rise underscore that statutory language encouraging new general office construction on Pier 30-32 is outdated and inappropriate. The existing pier's deterioration has been established as too expensive to repair to support heavier loads than its current uses, exposing it as a liability that should be removed unless it can be replaced for primarily maritime and other trust-consistent uses that justify the cost and impacts of constructing new fill in the Bay. Provisions to facilitate development of needed housing on Seawall Lot 330 may be retained.
2. Require state coastal agencies to study and report back to the legislature with recommendations on statutory changes or regulatory clarifications needed for them to find sea-level rise adaptation and climate resilience projects to be consistent with public trust requirements. The legislature should direct BCDC, the State Lands Commission and the California Coastal Commission to study how to best incorporate resiliency to sea

level rise and other climate impacts into their agency guidelines for determining allowable uses of properties under their jurisdiction, including those properties that are subject to public trust restrictions. The legislature should direct the agencies to promptly report back to the legislature on the study's findings and recommendations for statutory changes or regulatory clarifications needed to guide their agencies' future actions and facilitate adaptation to climate change and its impacts that are already being felt.

In fact, California's first Climate Adaptation Strategy in 2009, called upon the state's coastal and ocean agencies to "Identify areas where their jurisdiction and authority should be clarified or extended to ensure effective management and regulation of resources and infrastructure subject to potential sea level rise." Neither the legislature nor Governors Brown and Newsom ever acted upon that recommendation – the consideration and rejection of SB 273 should be an impetus to do so.
